This Enrollment Contract ("Contract") is made by and between the Agap	oe Orthodox Christian Preschool of Saints Peter and Paul Greek
Orthodox Church ("School") and the parent(s) or legal guardian(s) (refe	erred to hereinafter as "Parent," which includes the singular and
plural, as applicable) of	_ ("Student"). This Contract applies to the 2020-2021 academic
year. All persons signing this Contract agree to be jointly and severally	liable for the tuition and fees set forth herein. Parent's signature
on this Contract evidences Parent's understanding and agreement to be	e bound to the following terms and conditions:

- 1. Registration and Activity Fee. A \$250 non-refundable registration and activity fee is due by May 15, 2021 to reserve a place for Student in the Saints Kindergarten class. Parent understands that this fee applies to each child enrolled in the School. Parent further understands that the School may, in its sole discretion, determine not to administer the Saints Kindergarten class for the academic year, for example, due to low or insufficient enrollment. If the School does not administer the Saints Kindergarten class, the School will refund the registration and activity fee.
- 2. Tuition. The full tuition for the Saints Kindergarten class is \$5,850 and is referred to hereinafter as the "Tuition Amount."
 - (A) Installment Options. The Tuition Amount may be paid in one (1) payment or in nine (9) monthly installments.
 - (B) Method of Payment. The Tuition Amount may be paid by cash, check, or credit card.
 - (i) Checks. Checks should be made payable to "Saints Peter and Paul Greek Orthodox Church." Please add "Agape Preschool" to the memo section of each check.
 - (ii) Credit Cards. To setup automatic credit card payments, please contact Diane Bravos at (847) 729-2235.
 - **(C) Payment Due Dates.** The initial tuition payment is due by August 10, 2021 (whether paying the Tuition Amount in one payment or monthly installments). Each tuition payment thereafter is due by the 10th of each month. Automatic credit card payments will be charged to the credit card on file on the 10th of each month.
- **3. Tuition Discounts Available.** If Student is enrolled in a full class schedule, Parent will receive a 5% reduction towards the Tuition Amount if paid in full by August 10. Where Parent has more than one child enrolled in the School, Parent will receive a \$100 discount towards the Tuition Amount for one child. When Parent refers a new family to the School, Parent will receive a \$100 referral discount towards Tuition due. If Student begins classes during the school year, the Tuition Amount will be prorated for the first month as follows: (A) where Student begins classes on or before the 15th of a month, tuition is due for that entire month; or (B) where Student begins classes after the 15th of a month, tuition is due for each day attended that month.
- **4. Payment Schedule.** Options for tuition payment are listed below. The single payment option includes a 5% discount to the Tuition Amount. Parent elects the following payment option (please check one):

One payment of \$5,557.50	Nine monthly payments of \$650.00

- **5. Tuition Obligation.** Parent hereby agrees to pay the Tuition Amount according to the payment option selected in Section 4. In addition to the Tuition Amount, Parent should expect to incur other expenses, including but not limited to, healthy snacks, classroom supplies, special events, field trips, and similar kinds of expenses. Parent understands there will be no refunds or tuition allowances for vacations, illnesses, holidays, School closings, including due to inclement weather, or any other Student absences.
- **6. Late Payments.** Failure by Parent to pay any scheduled tuition payment shall be deemed a breach of this Contract. Past due balances or payments received after the 10th of the month will be assessed a \$20 late fee. In the event the School takes legal action to collect payments more than 60 days delinquent, Parent agrees to pay all collection costs, including but not limited to third-party collection fees, court costs, and reasonable attorney's fees. A \$30 fee will be assessed for any NSF checks or other forms of returned payments.

- **7. Withdrawal and Termination.** Parent may withdraw Student and terminate this Contract at any time and for any reason by providing WRITTEN notice at least 30 days before the date of withdrawal. Parent understands that, regardless of the reason for withdrawal, Parent is liable to pay tuition for the entire month in which the 30-day notice period ends whether Student attends classes or not. If Parent has paid the Tuition Amount with one payment, Parent will receive a refund for the full months following the end of the 30-day notice period.
- **8. Photos and Images.** Parent agrees to allow the Student's name, photograph, voice, image, and information to be used by the School for use in the School's publications, promotional materials, and website, without compensation and without prior notice. Parent releases and holds School harmless from any liability stemming from the use of the Student's name, photograph, voice, image, or information.
- **9. Governing Law.** This Contract and the rights and obligations of the parties shall be governed by and construed in accordance with the laws of the State of Illinois without reference to its conflict of law principles.
- **10. Waiver.** No singular waiver by School of any late payment or other breach of this Contract will operate as a waiver of any other late payment or breach.
- 11. Force Majeure: The School's obligations under this Contract shall be suspended immediately without notice during all periods that the School is closed because of force majeure events, including but not limited to, any fire, act of God, war, governmental action, act of terrorism, epidemic, pandemic, or other event beyond the School's control. If such an event occurs, the School's obligations under this Contract will be postponed until such time as the School, in its sole discretion, may safely reopen. In the event that the School cannot reopen due to an event under this section, the School is under no obligation to refund any portion of the Tuition Amount paid.
- 12. Amendment. This Contract may be amended only in writing signed by the School and the Parent.
- **13. Severability.** If any provision of this Contract is found to be illegal, invalid, or unenforceable, in whole or in part, that provision shall be severable and its invalidity or unenforceability shall not affect the remainder of this Contract.
- **14. Entire Agreement.** This Contract sets forth the entire understanding of the parties hereto with respect to the subject matter hereof and merges and supersedes all prior and contemporaneous oral or written understandings between the parties. Neither party makes any representations or warranties other than as expressly contained herein.
